# What is Pupil Premium?

- The Pupil Premium is an allocation of funds from the government to support children's learning and pastoral needs. Every child in receipt of free school meals (over the previous six years) and/or children of armed service personnel (over the previous six years) and/or children who fulfil criteria as a 'looked after' child or 'post looked after' child receives an allocation of funds. The Headteacher and Governing Body then decide how the money is used to support the children's education.
- All schools are required to report on the amount of funding received, how this is being used and the impact of the work undertaken.




# Principles

- At St Martin's East Woodhay CE (Aided) Primary School, we believe:
  - \*that all children have a right to high quality inclusive teaching and learning that meets their individual needs;
  - \*that all children have the right to learn in a nurturing environment where they feel a sense of belonging, safety and security.
- We understand that every child is an individual and we will consider the specific needs of every child, including any barriers to learning, when deciding on the type(s) and level of support and intervention to be allocated to that child.
- During the national lockdowns, we continued to use pupil premium to provide individualised support for children, whether they were learning in school or at home.

# Attainment

- At St Martin's East Woodhay CE (Aided) Primary School there were 4 children entitled to Pupil Premium, 1 child entitled to Post LAC Pupil Premium and 2 children entitled to Service Premium in the 2021 – 2022 academic year.
- Attainment data is included for children entitled to Pupil Premium in the 2021 – 2022 academic year. In order to maintain confidentiality, the attainment of all children is included as one group in the following data as opposed to splitting the data into individual year groups.
- Four children joined us from Ukraine during the year (1 in Spring and 3 in summer). All were new to English so have been assessed against the Bell Framework rather than ARE and are not included in the following data. All are making progress.
